**Rights & Duties of certified clients**

**Rights of Clients:**

- 1. Certified Clients under RMC capability scheme has right to use RMC Plant Scheme Certification Mark(s).**
- 2. Clients have right to RMC Capability Certification' mark, as any photographic reduction or enlargement**



- 3. The certified RMC plants have right to get a certificate by the certifying certification body. T**
- 4. The certified RMC plants have right to use the mark on the Delivery Tickets/Challans**
- 5. Certified clients have right to use the Certification Mark in publicity material, pamphlet, letter heads, other similar stationary, media for exchange of any communication, for promoting the awareness of the scheme, the Certification Mark, etc.**
- 6. The RMC plant has right to use the RMC certificate issued by ESCPL as part of publicity material.**
- 7. The Certified clients have right to display on the vehicles of transportation, the statement "It has been produced in an RMC plant certified under the RMC Plant Certification Scheme".**

**Duties of Clients:**

1. Clients have duty to sign the contract with QCI in the prescribed format.
2. It's duty of the client , to ensure the same color scheme , as depicted above.
3. It is duty of the Certified clients , not to use RMC Plant certification , in a manner to imply that the product (ready mixed concrete) is certified. The Mark shall not be displayed on RMC transportation vehicles.
4. It's duty of the Clients , not to use "The RMC PlantScheme Certification Mark"on other documents accompanying the supply like Test Certificate,etc.
5. It's duty of the Clients , to ensure that the Mark is used only with respect to the RMC plant certified and it shall notgiveimpression that the non-certified, individual plants of a cluster or a company are also certified.
6. It's duty of the certified RMC Plant , not to make any misleading claims with respect to the CertificationMark.
7. It's duty of the certified RMC Plant not use the Certification Mark in such a manner as to bring the Scheme Owner,QCI, intodisrepute.
8. It's duty of the certified RMC Plant , that upon suspension or withdrawal of its certification, discontinue use of the Certification mark, in anyform.
9. It's duty of the certified RMC Plant , upon suspension or withdrawal of its certification, to discontinue use of all advertising matter that contains any reference to its certificationstatus.
- 10.If a certified RMC plant's certification is suspended; its certificate cancelled, withdrawn or discontinued, it is the duty of certified RMC Plant to discontinue the use of the Certification Mark from the date from which the certificate stands suspended, cancelled, and withdrawn or discontinuation comes into force.
11. It's duty of the certified RMC Plant , to pay an annual fee per plant to QCI, for the use of RMC Plant Certification Mark as prescribed from time to time.
